

SUPPORTING THE WHOLE CHILD AND THE WHOLE FAMILY



The Family Resource Center offers tailored programs and services to create a stable home and learning environment. The services include the Families Achieving More life coaching, skill building, career counseling, resource connections, financial literacy, crisis supports, and parent education.



40 families participated in Families Achieving More Life Coaching



20 families connected to housing in partnership with the Hope Center 87 families referred to DEHAP, received rental or utilities assistance, or connected to food benefits



22 families received direct mental health services

STUDENT ADVOCACY SYSTEM

Connecting Supports Through Advocacy



At CEB, we get to know and understand the individual needs of each student. Our individualized Student Advocacy System provides every child with an Advocate - a near peer mentor, navigator, and coach - whose job it is to connect the student with resources and opportunities in a way that helps each student reach her goals.

Advocates are champions; adults dedicated to helping students navigate their way through everyday life toward a successful future.

How It Works

- 1:1 Mentorship through weekly meetings
- Support Network Connector
- Student-Led Goal Setting
- SEL Skill Building

Our Student Advocates connect deeply with students to identify their students' interests and work together with them to overcome any barriers that stand in the students' way.



Increasing Access to Health Services



In partnership with CEB and Kuumba Academy, ChristianaCare launched a school-based health center (SBHC) increasing student access to quality healthcare. The SBHC was made possible thanks to the Delaware Department of Education's Wraparound Services Grant. This new SBHC will provide access to acute and preventative health care including vaccinations, physicals, screenings, and mental health services.

Growing to Meet the Needs of Our Community

Coming Soon: Youth Development Center



We are excited to announce the launch of our Youth Development Center which will expand CEB's capacity to serve the community. The Youth Development Center will provide Wilmington youth with a safe, enriching and dynamic place to learn, grow, and play, both during and after school.

The 45,000 sq. ft. complex will be an educational hub for the community and will provide critical infrastructure for athletics and the arts. Integrated learning spaces will provide Wilmington's youth with a safe haven to enjoy expanded opportunities for learning, recreation, and social gathering. Students will participate in a variety of extra-curricular activities in athletics, arts, post-secondary career exploration in STEM, infrastructure trades, fin-tech, and health services, and other college and career pipeline activities.

A New Advocacy Model

In partnership with Kuumba and the Delaware Department of Education CEB will provide Student Advocacy services and "Families Achieving More" programming to all 160 kindergarten and first grade Kuumba students.



Starting next winter, every student in Kindergarten & first grade will have the support of a Student Advocate and every family will be enrolled in our Families Achieving More program. We look forward to this opportunity which opens the way for CEB to work with students and families from Kindergarten through postsecondary studies.
